### INSTRUCTIONS TO BIDDERS

1. Technical bid/proposal should accompany the following:
  - a. Certificated that Bid Security in the shape of call deposit (original) has been enclosed in financial bid.
  - b. Enlistment Order of C&W Department (Photocopy)
  - c. Renewal of Registration for Current Financial Year 2021-22 (Photocopy)
  - d. National Identity Card (CNIC Photocopy)
  - e. PEC registration copy calendar for year 2021-22
  - f. Form H of the Company/Firm.
  - g. Documents showing general capabilities, general & relevant experience, personnel capabilities, financial soundness, Income Tax/NTN & KNTN Certificates.
  - h. Any other document to support the technical bid.



- i. Technical evaluation will be carried out on marks threshold in passing all the fields/categories including PEC Registration, Enlistment with C&W & Others Government Works Departments, Tax Payer Proof, and Relevant Experience in past 03 Years, Performance, Technical Personnel, Financial status, Auditors report, Managerial capabilities, Litigation status etc.
2. Bid Solicitation documents including Priced BOQ/Engineer Estimate, Instructions to Bidders (ITB), evaluation criteria can be obtained from the office of the undersigned at the cost of Rs.1000/- PKR in form of cash (non-refundable) by submitting written request mentioning on company's letter head during office hours.
3. The bidders must be enlisted with the Khyber Pakhtunkhwa Revenue Authority as per KPPRA Rules.
4. The envelope shall be marked as "TECHNICAL BID" and "FINANCIAL BID" and in BOLD and LEGIBLE letters to avoid confusion. Similarly, the bidder shall seal both bids in separate envelopes.
5. The tender must be accompanied by **2% earnest money** of the **Engineer Estimate** in the form of call deposit /bank draft (Refundable) separate for each category of work drawn in the favor of Director ZamungKor, Peshawar. Tender (s) without earnest money will not be entertained.
6. The KPPRA Notification **S.R.O.(13)/Vol:1-21/2021-22;** dated Sep 15,2021/5335-48 will be implemented for contractor quoting their bids more than 15% below Engineer Estimate shall submit along with their bids an **Additional Security** to the extent of their bid/rates more than 15% below on engineer estimate in the form of percentage otherwise the bid will be considered as non-responsive.
7. The competent authority ZamungKor reserves the right to accept or reject any or all tenders, as KPPRA per rules.
8. It is mandatory to all contractors, who are participating in the bidding should sign every page of their broacher with page numbering and mentioning here total No of pages i.e. 1 to 200 before submitting. Unsigned broacher will not be considered in the bidding process.
